We have completed FF testing and assessment to establish an entrance level register from which to fill the three FF vacancies and plan to make conditional job offers the first week in June. Testing and assessment to establish registers from which to fill the Lieutenant and Captain's vacancies is scheduled for June 2022.

We have sufficient candidates to complete testing and assessment for both the Lieutenant and Captain classifications. Staff is focused on having all vacancies filled within 60 to 90 days. We will update the Commission periodically as we move ahead.
